### VII. Executive Director's Report

(Information/Report)

- Mr. MacGaffey reported that we conducted a full disaster drill with our Staff which was a great success.
- Discovery had another successful winter session with our Athlead ELOP program.
- This Monday, Discovery had a great visit from Arroyo's Vista ILT. They visited many of our math classrooms.
- We are back in the process of searching for a school nurse for the Health Office.
   We currently have substitute Nurses covering the Health office in the meantime.
- Enrollment for next year will start in Feb and we will have a Parent Night for new incoming 7<sup>th</sup> graders, on February 6<sup>th</sup>.
- Our ELPAC testing will also begin in February and we would like to praise Mrs. Alamo, Mrs. Ulloa and all teachers for helping with this process.
- After school tutoring began this week and we are looking forward to that.
- Mr. MacGaffey showed some recent data from California School's Dashboard which demonstrated student growth and participation rate between 2022-2023.
- Mr. MacGaffey presented an overview of Discovery's Dashboard data. He happily reported that no students declined. Mr. MacGaffey gave kudos to our resource teacher Mrs. Peterson and to all our teachers for their amazing work with our students.
- Mr. MacGaffey shared how Discovery is the only charter school in San Diego County to be in either the blue or green tier in all 5 metrics on the California Dashboard.
- Mr. MacGaffey shared the student climate survey data.
- Mr. MacGaffey also shared the SWIS data for Discovery and was pleased that rate for incidents was cut in half.
