V. Executive Director's Report

(Information/Report)

- Mr. MacGaffey presented the behavior data and interventions for Discovery. The
 amount of referrals decreased on average and the data looked very positive. This is
 due to the interventions we have put in place.
- Mrs. Alamo and Mr. MacGaffey are starting student council this week. Student campaigns will start soon and everyone is excited about the leadership opportunities for the students.
- Mr. MacGaffey shared some pictures about Discovery's rainy day, older student buddy ups, and his time with the TK's during lunch.
- Mr. MacGaffey shared information on our new afterschool biking club, Sprockids, which is very popular with the students.
- We had our first DELAC meeting here at Discovery which was well attended and was a successful meeting. We were able to elect a DELAC Board and shared information for our EL parents.
